## CV NOTE

**Thanos Pallis** is a Professor of Port and maritime economics and policy at the Department of Maritime Studies, University of Piraeus, Greece, where he also directs the Integrated Port Economics & Management Laboratory. He is the founder and co-director of *Port Economics* and the Vice-Chair of the Port Performance Research Network (PPRN). He co-authors the book *Port Economics, Management & Policy* (Routledge, 2022).

### Academia

Thanos was a Fulbright Scholar (2008-11) at Columbia University, New York, US (Centre for Energy, Marine Transportation & Public Policy), Professor at the Department of Shipping, Trade and Transport, University of the Aegean and the National and Kapodistrian University of Athens in Greece, Adjunct Professor at the Centre for International Trade and Transportation, Dalhousie University, Halifax, Canada, and Visiting Professor at School of Management, Universidad de Los Andes Colombia. Visiting professorships include Athens University of Economics, Greece; University of Antwerp, Belgium; University of Old Dominion, Virginia, US; University of Texas A&M, US; Parthenope University of Naples; & Hong-Kong Polytechnic University.

Thanos won twice the “Maritime Economics & Logistics Best Paper Award” of the International Maritime Association of Maritime Economists: in 2017, leading research on private entry in cruise terminal operations, and in 2008, leading research on container port concession *agreements*. He won the “Best European Study 1999” Competition, organized by the European Community Studies Association. In 2024 he was included in the 2% of the world’s most cited researchers in the realm of transport & logistics (citations > 6.800 / h-index = 43), His books examine the *Port Economy* (in Greek), the *European Port Policy* (published in English, Japanese, and Greek), *the Common EU Maritime Transport Policy* (in English and Greek), *Maritime Transport: The Greek Paradigm* (in English), and *Port Economics and Policy* (in English). He is the immediate past President 2018-2022) and is currently a Council member of the International Association of Maritime Economists (IAME).

He received his BSc (Economics) from Athens University of Economics, Greece (1992), his MA (Economics of European Integration) from Exeter University, UK (1993), and a PhD from the School of Management, University of Bath, UK in 1998.

### Professional Expertise

Currently a member of the International Association of Ports & Harbors (IAPH) Risk and Resilience Committee and the IAPH Cruise Committee, Thanos has worked in ports and maritime logistics on all different continents. He has contributed to research in North America for Transport Canada (Port Performance Indicators and Benchmarks; Atlantic Gateway Research Initiative; Canadian Port governance reform; and the Association of American Port Authorities (Port Customer Service Initiative); in South America on container port development (Chile) and port policy (Colombia); in Asia defining a maritime strategy (Turkey; Bangladesh); in Africa on port privatization and concessions (UNCTAD); in Europe for OECD, Cruise Europe, and MedCruise on cruise ports. A regular advisor of the European Commission, national governments, and European ports on port issues, he was Secretary-General of MedCruise (2013-17), the association representing more than 150 cruise ports in 20 countries in the Med. He has been the chief consultant of UNCTAD on the implications of the COVID-19 pandemic on maritime supply chains.

In Greece, Thanos served as General Secretary for Ports & Port Policy at the Ministry of Development, Competitiveness, and Shipping of the Hellenic Republic and was a Member of the National Council for the Development of State Assets (2011-12). His responsibilities included representing Greece at the European Ports Policy decision-making and negotiating with the IMF/European Commission/ECB Troika on port policy reforms.

Contract research includes projects and consultancy studies examining the structures of the European port industry and other maritime topics – and has been financed, among others, by competition authorities in Europe and North America, port authorities, associations representing port and shipping interests, and several terminal operators, shipping and maritime-related companies.
